If you wish to apply for the PA State Grant, **a separate application**, which may be obtained from [www.pheaa.org](http://www.pheaa.org), is required. You must also have completed and submitted your 2011-2012 FAFSA for consideration. Please be aware that students who are eligible for the PA Grant are permitted to receive 8 full-time semesters of grant awards and must maintain satisfactory academic progress for future consideration. If you receive a PA Grant in the summer, it **will count** toward the 8 full-time semesters of eligibility. Visit [www.pheaa.org](http://www.pheaa.org) for more information.

In many instances, the aid that we are able to award is not enough to cover your expenses, so many students utilize Federal Direct PLUS Loans or Alternative Loans, which require separate applications and credit checks, to cover their balances. Please note that while you must be enrolled for at least 6 credits to receive Federal Direct PLUS Loan funding, enrollment requirements vary from lender to lender for Alternative Loans and that you may be able to secure Alternative Loan funding if you are enrolled for less than 6 credits.
